

Minutes of Evaluation Financial bid opened on 19.04.2023 at Regional Office, Chennai.

Name of work: PIU - Salem - Permanent Rectification of Black Spot TN-(02)-468 & TN-(02)-216 by Constructing a Vehicular Underpass (VUP) (1 x 12m x 5.5m) at Km.177/880 (Pannapatty Junction) along with Service Road in the Project of Krishnagiri - Thumbipadi Section of NH-44 (Old No.NH-7) in the State of Tamil Nadu on EPC mode (Tender ID: 2023\_NHAI\_145008\_1).

In accordance to the decision taken by the Tender Evaluation Committee during the Technical evaluation of bids and on approval from Competent Authority, the Tender Committee has downloaded the financial bids of 06 (Six) technically qualified bidders on 24.03.2023 from e-tender portal.

2. The Bid capacity status of the bidder prior to the date of opening of Financial Bid was obtained and it is found that Bid capacity is more than the minimum requirement for all the bidders.

3. The details of bid amount quoted by the bidders as per the price bids uploaded by them are given below:

4. The Comparative Statement of the Financial Bids quoted by the bidders and their position with respect to the estimate amount is enclosed as Annexure-I.

5. It is observed by the Tender Evaluation Committee that the lowest quoted bid of Mr. P Paramasivam, Omalur, Salem for Rs. 16,82,97,220/- is at 27.27% less than the estimated cost. Therefore, Tender Evaluation Committee has recommends that the work may be awarded to the lowest bidder on receipt of Bank Guarantee for an amount of Rs.50,48,917/- towards Performance security and Rs.33,64,556/- towards Additional Performance Security as per Section 2.21.1, Part-I of RFP.
