- As per Clause 2.10.1 of RFP, within 7 (Seven) days from the date of issue of this LOA, you are required to submit a Performance Security consisting of (a) a crossed account payee demand draft/Pay Order, amounting to Rs. 41,43,000/- (Rupees Forty One Lakh Forty Three Thousand Only) and (b) a bank guarantee valid for a period of 14 (Fourteen) months from the Date of LOA, in the prescribed format for Rs. 41,43,000/- (Rupees Forty One Lakh Forty Three Thousand Only). However the Competent Authority has approved to allow you to deposit the performance security by 24.03.2023 as the regular contract with existing agency is upto 29.03.2023.
- The Bid Security of Rs. 10.00 Lakh shall be forfeited by the Authority in case you fail to furnish the required Performance Security within the specified period, out of common bid security (BG) available with the Authority. As per Clause 3.6 of RFP, you shall also be required to sign the contract within Three (03) days from the date of submission of the Performance Security, take over the toll plaza and start the user fee collection within Two (02) days of signing the contract agreement and on failure to do so, the entire Performance Security including the bank guarantee is liable to be forfeited and invoked.

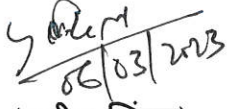
