AGREEMENT

This agreement is made in Trichy on 11.05.2023 between M/s.Kareem Cabs Proprietor having office No 28/19-33A Anna street, Kamaraj Nagar, Ariyamangalam, Trichy - 620010 hereinafter referred to as "the party of the **FIRST PART**" and The Project Director, Project Implementation Unit - Trichy, **National Highways Authority of India**, No.6, 1st Floor Third Main Road, Ponnagar, Trichy- 620 001, hereinafter referred to as "the party of the **SECOND PART**".

WHEREAS the party of the First part agreed to provide One No of Indigo or Equivalent Vehicle and One No of Bolero/Scorpio Equivalent Vehicle not older than 3 years of purchase to the office of the party of the second part and the first part agreed to provide the services agreed upon as per terms and condition set forth herein in this agreement.

NOW THIS AGREEMENT WITNESSETH AS UNDER:

1. That the party of the first part shall provide a good quality One No of Indigo or Equivalent Vehicle and One No of Bolero/Scorpio or Equivalent Vehicle and the model shall be new or not older than 03 Years. Initially for a period of 12 months on monthly hired basis to the party of the second part.
2. That the monthly rental of Rs.65,400/- will be paid for the use of the Vehicle with the ceiling of 36000 Km for One Year and Rs.22/-per km for the Payment of extra kms will only be considered at the time of closure of the year/termination of the agreement whichever is earlier, if the average running during the year exceeds the specified kms i.e 36000 Km by the party of second part to first party for the Bolero/Scorpio or Equivalent Vehicle and the monthly rental of Rs.41,400/- will be paid for the use of the Vehicle with the ceiling of 36000 Km for One Year and Rs.14/- per km for the Payment of extra kms will only be considered at the time of closure of the year/termination of the agreement whichever is earlier, if the average running during the year exceeds the specified kms i.e 36000Km by the party of second part to first party for the Indigo Equivalent Vehicle. The monthly rental will be calculated & paid based on actual usage of Km of vehicle for the respective month.
3. The first part shall also provide the driver having a valid driving license. The valid registration, insurance fitness certificate etc to be ensured by the local agency. All necessary taxes for operating the vehicle shall be fully paid by the agency as per prevailing Motor Vehicles Act with comprehensive insurance cover.
4. The vehicle shall be a dedicated one for exclusive use of NHAI Officials, as required, for all days regularly in a month. NHAI will not be responsible for parking / accommodation / facility of meals for the driver and the first party should make the above arrangements on their own.
5. The vehicle shall be available 24x7 exclusively for this office and itshall not be utilized for any other purpose during the contract period.
6. All cases related to accident / damaged/compensation shall be the responsibility of the first part. The first part shall provide a substitute vehicle immediately.
7. The first part shall bear all expenses required for keeping the vehicles in smooth running condition such as fuel, lubrication oil & other consumables, necessary service & maintenance, driver's repairs & replacement etc. The first part should ensure that sufficient fuel is always available for travel.

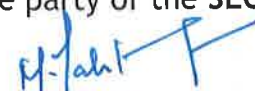
8. The first party shall be responsible for all the acts and deeds of the drivers of vehicle. The Authority will in no way be responsible for violation of traffic rules and / or other losses either by driver of the vehicle or by the Agency.
9. The first party shall ensure proper cleanliness and hygiene condition in the vehicle and upholstery / interior of the vehicle shall be maintained in excellent conditions.
10. The Agency shall provide experienced and well - behaved Drivers having valid driving license. The driver should be in sound mental and physical condition and perform the duty sincerely and diligently. He should not take alcohol or any other intoxicants or smoke or any misbehavior while on duty hours. The Agency shall replace the driver within 24 hours in case of any misconduct noticed by NHAI.
11. The quoted rates for hire charges / month include salary of driver / month, cost of all lubricants, full routine maintenance, toll tax, permit fee, toll fee, parking charges if any including cost of spares etc & any other incidentals as may be required. The quoted rates shall be excluding of all taxes if any.
12. In case of vehicle failure, the agency shall arrange for an alternative vehicle immediately or shall bear the actual expenses incurred by the officer for hiring a taxi. If the substitute vehicle is not provided a penalty of Rs. 2,500/- per day shall be affected from the bills of agency.
13. The counting of distance will be taken from reporting place of the concerned officer and to the termination place only. The daily duty chart with the mileage covered during the day should be got counter signed from the officer concerned daily.
14. That the required documents relating to payment of road tax, insurance, registration, etc. should always be available in the Vehicle. The vehicle provided should have permit to travel in the entire state of Tamil Nadu
15. The First part should submit their bill in duplicate along with logbook with in 1st week of succeeding month for payment. The payment will be made within 15 days on monthly basis as per certificate given by officer concerned after verifying the total mileage of the month on submission of bill.

17. The contract can be terminated on culmination of contract or at any time if the performance of service is not satisfactory after notice of 7 days.
18. The first party shall abide by the terms and conditions which forms a party of this agreement.
