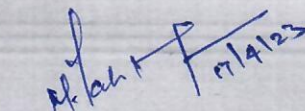
4. On comparing the rates quoted by the above two bidders, it was found that the rates quoted by M/s. Kareem Cabs at a monthly rent of Rs.65,400/- up to 3,000 Km and Rs.22/- extra for each Kilometer beyond 3,000 Km for Bolero/Scorpio Equivalent and Rs.41,400 up to 3,000 Kms and Rs.14/- extra for each kilometer beyond 3,000 Km for Indigo Equivalent Vehicle is the lowest among the two bidders.

As such, the Tender Committee has unanimously decided to recommend the lowest quotation of M/s.Kareem Cabs at the monthly rate of Rs.65,400/- up to 3,000 Km and Rs.22/- extra for each Kilometer beyond 3,000 Km for Bolero/Scorpio Equivalent and Rs.41,400/- up to 3,000 Km and Rs.14/- extra for each Kilometer beyond 3,000 Km for Indigo Equivalent on hiring basis for the exclusive use of Manager (T) and Site Engineers in PIU-Trichy. Upon approval of Competent Authority, Agreement will be executed with the selected bidder, at the earliest.
