Minutes of Meeting for Expression of Interest for Empanelment of Plantation Agencies to participate in tender process of Avenue Plantation/Median Plantation Works along National Highways under the jurisdiction of RO Madurai.

Upon approval of the Competent Authority, Expression of Interest (Eoi) for empanelment of Plantation Agencies had been uploaded in the e-tender portal and NHAI website on 28.02.2023 with last date of submission as 29.03.2023.

2. The following Committee was constituted to evaluate the EOIs received from the Agencies / Applicants for empanelment of Plantation Agencies under Regional Office, Madurai.

4. The details of bids received and tender fees was furnished to F & A Unit, RO Madurai. F & A Unit, RO Madurai confirmed the receipt of tender fees of all the 17 No's of bidders.

5. The Committee evaluated the 17 EOLs' and the following are submitted:

i. 14 No's of the Agencies have not submitted documentary evidences towards the experience of the Resource persons with the agency as per Clause 3.2 of the Eol. Even after providing the bidders, the opportunity to provide documentary evidences towards the experience of the resource persons within a period of 7 days, the following 4 No's of Agencies failed to submit the same:

- a) M/s. Luvkush Enterprises, Wardha,
- b) M/s. Agrisense Landscape, Gurgaon,
- c) M/s. Rainbow Greeners, Nagpur &
- d) M/s. G.B.Greenway, Maharashtra

Hence, the committee unanimously recommends to disqualify the above 4 No's of Agencies.

ii. M/s. Snehal Kisan Nursery, Wardha has submitted a CV of B.Com graduate for the Team Leader. However, as per Clause 3.2.1 of Eol, the the Team Leader must have Post-Graduation/Graduation in Forestry/Agriculture/Horticulture or other relevant stream. Hence the committee unanimously recommends to disqualify M/s. Snehal Kisan Nursery, Wardha.

iii. M/s. Shubhank Kisan Nursery, Wardha has provided experience certificate for 7.36 lakhs. In the certificate it is mentioned that the amount of 7.36 lakhs is for plantation of bamboo and garden landscape work at various site done by the agency for a period of 2 years. As per Eol, to be categorized as Category A, the agencies should have plantation experience of implementing minimum one plantation project of Rs. 5 lakh - 20 lakh project cost. Hence the committee recommends to disqualify M/s. Shubhank Kisan Nursery, Wardha.

6. Further, with respect to the documents prescribed in the EOI, the committee based on the value of plantation works done by the agencies as per Cl. 2 of EOI recommends for empanelment of Plantation Agencies under Regional Office, Madurai in two categories as follows:
