Sub.: Improvement of existing alignment of Pandharpur Town (part bypassed section of NH-965 from Km 36.230 to Km 44.230) from Chhatrapati Shivaji Maharaj Chowk to Wakhari on EPC mode - **Outcome of Technical Evaluation of bids - Reg.**

- While computing the Technical Capacity of the JV, the receipts/work executed in F.Y. 2022-23 in case of Project Code A, B & C of the Lead member and Project Code D of the Other member has not been considered pursuant to clause 2.2.2.6 (ii) read with clause 2.1.13 of the RFP. Further, Project Code C of Lead Member and Project Code D of the Other Member has not been considered eligible for computing the Technical Capacity pursuant to clause 2.2.2.6 (ii) read with clause 2.1.13 of the RFP since the amounts received/ work executed, during last 5 financial years i.e. from 2017-18 to 2021-22 are less than Rs. 5.74 crore. Accordingly, the threshold Technical Capacity of the JV has been assessed as Rs. 96.64 cr. as against the minimum requirement of Rs. 114.75 cr. **Therefore, the Bidder stands disqualified for not meeting the minimum required Threshold Technical Capacity of Rs. 114.75 crore as per clause 2.2.2.2 (i) of the RFP.**
- The Bidder was asked to clarify the experience of having completed one similar work of 20% of Estimated Project Cost Rs. 22.95 crore in last 05 financial years ending on 31.03.2022. The bidder in its response clarified that Project Code A of the Lead Member may be considered as completed project. However, the referred Project has not been considered as complete since only Rs. 124.84 Cr. of work has been executed as on 31.03.2022 out of the total project cost of Rs. 165.20 Cr. representing 75.56% completion i.e. less than 90% as per clause 2.2.2.2 (ii) of the RFP. **Therefore, the bidder stands disqualified for not meeting the minimum requirement of having completed one similar work of 20% of Estimated Project Cost Rs. 22.95 crore under 2.2.2.2 (ii) of the RFP.**
- The Lead Member neither submitted the audited annual accounts nor the statutory auditor's certificate certifying the net worth as on 31.03.2022. A clarification was sought in this regard from the bidder. The bidder in its response submitted a certificate of Net Worth certified by a chartered accountant. However, the submitted certificate of net worth has not been considered acceptable due to following reasons:
 - Networth is certified by D.S Darekar & Co., Chartered Accountants who is not the statutory auditor of the Lead member. The statutory auditor of Lead Member is J D Thorat & Co. Chartered Accountants.
 - The net worth certificate specifies that amount of net worth of Rs. 7.51 cr. is based on unaudited annual accounts as on 31.03.2023. However, as per the clause 2.2.2.9 (ii) read with clause 2.1.13 of the RFP, the net worth is required to be certified as on 31.03.2022 and must be based on audited annual accounts.
 - Bidder has not furnished audited annual accounts of lead Member for the F.Y 2020-21 and F.Y 2021-22.

In view of above, the net worth of the Lead Member as on 31.03.2022 is not assessable and therefore considered as Nil. **Therefore, the bidder stands disqualified for not meeting the minimum required net worth as per clause 2.2.2.3 (i) of the RFP.**
