Minutes of Meeting of Tender Evaluation Committee (Financial Evaluation) for the work of "Emergency repair works in Trichy to Madurai section of NH 45B (New NH 38) in the state of Tamil Nadu on Item Rate Basis with an estimated cost of Rs.16,73,055 (excluding GST). (TENDER Ref No: NHAI/PD/TRY/TENDER/03/2023 & TENDER ID: 2023_NHAI_148237_2).

1. Committee evaluated technical bids and recommended the following;

2. Subsequent to approval of Competent Authority, the technical evaluation Minutes was uploaded in Government CPP Portal and consequently financial bids submitted by the technically qualified bidders have been decrypted on 18.04.2023 and the amounts quoted by them are as under;

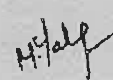

2	544078	M/s Sri S Subbiah & Company, Madurai	Rs.19,30,036	Above 15.36% L-2

3. Upon Noticing the rate quoted by the bidders, M/s. PR & Co, Madurai above 9.69% of the estimated cost is less than that of the rates quoted by M/s Sri S Subbiah & Company, Madurai, which is above 15.36% of the estimated cost. But still the rates quoted by the L1 bidder is on the higher side, hence the L1 bidder may be requested for a negotiation, considering the urgency of the emergency work. Hence, the Committee in the minutes of meeting of Tender Evaluation Committee (Financial Evaluation) dated 18.04.2023 recommended for negotiating with the L1 bidder to quote lesser amount.

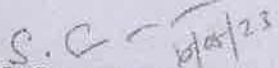
4. As per the recommendation of the committee, NHAI PIU Trichy vide letter NHAI/PD/TRY/Tender/03/2023/764 dated 25.04.2023 has requested the L1 bidder to quote a lesser amount considering the urgency of the work. In response the L1 bidder M/s. PR & Co, Madurai vide letter PR/TRY-MDU/RW/01 dated 09.05.2023 (received by email) has submitted to execute the above work at 2.25% above the estimated cost.

Hence the tender evaluation committee unanimously recommends to accept the rate quoted by the bidder and to award the instant tender work to the L-1 bidder, M/s. PR & Co, Madurai @ 2.25% above the estimated cost (Rs.16,73,055 excluding GST) i.e for an amount of Rs.17,10,197/- (excluding GST).
