1. Regional Office, NHAI, Madurai invited bids vide Tender ID: 2023\_NHAI\_148284\_1 for the works of "Periodic Renewal of Tuticorin - Tirunelveli Section from Km 6/160 to Km 47/250 of NH-138 in the State of Tamil Nadu on Item Rate Basis" with an estimated cost of Rs.4518.84 Lakh (excluding GST).

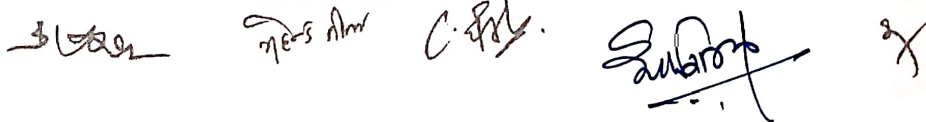
2. A committee has been constituted with the following members to carry out tender evaluation;

Last Date of submission of e-bids was scheduled on 08<sup>th</sup> April, 2023 up to 11.00 AM and last date of submission of physical form of EMD/Bid Security was scheduled on 10<sup>th</sup> April, 2023 up to 01.00 PM. The date of technical bid opening was scheduled on 10<sup>th</sup> April, 2023 @ 03.00 PM.

4. Accordingly, the Committee opened the e-bids received through online (on 10.04.2023) and decrypted. Totally 8 Nos. of Bids were received through online. The details of bids received are as under;

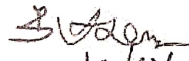

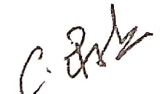

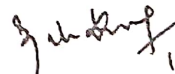
