- As per Clause 2.10.1 of RFP, within 7 (Seven) days from the date of issue of this LOA, you are required to submit a Performance Security consisting of (a) a crossed account payee demand draft/Pay Order, amounting to **Rs. 2,60,39,000/- (Rupees Two Crore Sixty Lakh Thirty Nine Thousand Only)** and (b) a bank guarantee valid for a eriod of **14 (Fourteen) months** from the Date of LOA, in the prescribed format for **Rs. 2,60,39,000/- (Rupees Two Crore Sixty Lakh Thirty Nine Thousand Only)**.
- The Bid Security of **Rs. 63.18 Lakh** shall be forfeited by the Authority in case you fail to furnish the required Performance Security within the specified period, out of common bid security (BG) available with the Authority. As per Clause 3.6 of RFP, you shall also be required to sign the contract within **Three (03) days** from the date of submission of the Performance Security, take over the toll plaza and start the user fee collection within **Two (02) days** of signing the contract agreement and on failure to do so, the entire Performance Security including the bank guarantee is liable to be forfeited and invoked.
- In the event of your failure to submit the Performance Security, the Letter of Acceptance for award of contract in your favour shall automatically be terminated without further notice. In such a case, your engagement shall forthwith automatically stand terminated and thereupon, without prejudice to any other rights and remedies available to the Authority and the Authority shall be entitled to appoint another Contractor at your risk and costs and consequences.

5. Please convey your unconditional acceptance by signing on the original of this letter as per Clause 3.3.5 of RFP and submit the required Performance Security within the specified period so that the Contract could be signed within the specified period.
