- As per Clause 2.10.1 of RFP, within 7 (Seven) days from the date of issue of this LOA, you are required to submit a Performance Security consisting of (a) a crossed account payee demand draft/Pay Order, amounting to Rs. 56,27,000/- (Rupees Fifty Six Lakh Twenty Seven Thousand Only) [NHAI, Canara Bank Current A/c. No.8598201005819; IFSC Code: CNRB0008598] and (b) a bank guarantee valid for a period of 14 (Fourteen) months from the Date of LOA, in the prescribed format for Rs. 56,27,000/- (Rupees Fifty Six Lakh Twenty Seven Thousand Only). However the Competent Authority has approved to allow you to deposit the performance security by 24.04.2023 as the regular contract with existing agency is upto 28.04.2023.
