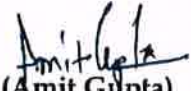

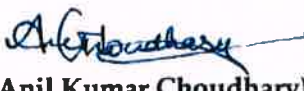
Tender Opening Date: 19.04.2023

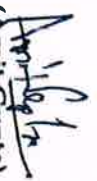
