7. In view of above deliberations, Committee decided that the result of the technical evaluation may be uploaded on the e-tender portal.

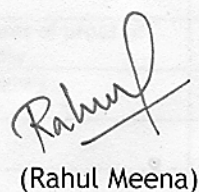
8. In view of the above deliberations, the committee decided that financial bid of the bidders may be opened on 25.05.2023.

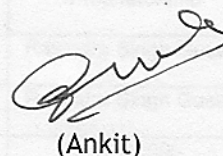

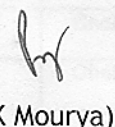
