

**NATIONAL HIGHWAYS AUTHORITY OF INDIA

“Providing, Running & Maintenance of Commercial Vehicles [1 No. of Scorpio/Bolero or Equivalent Type and 3 No. of Indigo (or) Equivalent Type] on hire basis - (Second Call) (Tender ID: 2023_NHAI_152644_2)”

1. PIU, Dindigul invited E-bids vide Tender ID: 2023_NHAI_144878_1 for providing, running & maintenance of 3 Nos. of Commercial Vehicles on hire basis for the office use of PIU, Dindigul, bid documents for the subject tender work. However, as there was no bids received in the CPP Portal, it was decided to invite fresh bids under second call vide Tender Ref ID: 2023_NHAI_144878_2.
2. Upon receipt of no bid during second call (Tender Ref: 2023_NHAI_144878_2), this office had invited bids under Third Call vide 2023_NHAI_144878_3 wherein 1 No. of Bid was received. Consequent upon completion of Technical Bid Evaluation, Financial Bid was opened on 19.04.2023 and observed that, the rates quoted by the bidder (single bid) i.e., M/s VETRI Agency, Dindigul are on higher side i.e., **Rs. 75,000/- per vehicle/per month** for a period of one year, hence, the Committee has not acceded to the quoted rates.
3. Also, subsequent to the joining of Manager (Tech.), PIU, Dindigul on 10.04.2023 (FN) it was decided to invite fresh bids under separate call duly including 1 No. of Bolero/ Scorpio or equivalent along with 3 No. of Indigo or equivalent type of vehicles for PIU, Dindigul. As such, bids were invited under Tender Reference No. 2023_NHAI_152644_1, however, there was no bid received during the first call. Hence, it was decided to re-invite bids under 2nd call (Tender ID: 2023_NHAI_152644_2) duly allowing seven days of time i.e., Last date to submit bids on 19.05.2023 (upto 17.00 Hrs) and Opening of Bids were scheduled on 20.05.2023 at 17.00 Hrs. Accordingly, 2 No. of E-Bid was received within the stipulated time.
4. Further to mention that, this office vide Office Order No. NHAI/PIU/DGL/ Vehicle Tender/2023/905 dated 26.04.2023 has constituted the following Committee for evaluation of Vehicle tender bids;

As above, bids submitted by **M/s Vetri Agency, Dindigul & Shri S Kannan, Dindigul** have been identified as **"Responsive"** with reference to the Technical criteria set forth in RFP, the Tender Evaluation Committee has recommended to accept both bids and to open the financial bid submitted by the Responsive Bidder to know the quoted amount for the hiring of Vehicles [3 No. of Indigo/Equivalent & 1 No. of Scorpio/Bolero Equivalent] to take further course of action, at the earliest, since, the instant tender is already under **Second Call** (including the previous tender references, it is actually on 5th call). Also, the extension of time approved for the existing vehicle hiring agency is about to expire by 31.05.2023. Hence, the Committee decided to recommend to open Financial Bids and to evaluate the financial bids at convenient date.
