- As per Clause 2.10.1 of RFP, within 7 (Seven) days from the date of issue of this LOA, you are required to submit a Performance Security consisting of (a) a crossed account payee demand draft/Pay Order, amounting to Rs. 2,26,81,000/- (Rupees Two Crore Twenty Six Lakh Eighty One Thousand Only) [NHAI, Canara Bank Current A/c. No.8598201005819; IFSC Code: CNRB0008598] and (b) a bank guarantee valid for a period of 14 (Fourteen) months from the Date of LOA, in the prescribed format for Rs. 2,26,81,000/- (Rupees Two Crore Twenty Six Lakh Eighty One Thousand Only). However the Competent Authority has approved to allow you to deposit the performance security by 12.06.2023 as the regular contract with existing agency is upto 17.06.2023.
- The Bid Security of Rs. 54.30 Lakh shall be forfeited by the Authority in case you fail to furnish the required Performance Security within the specified period, out of common bid security (BG) available with the Authority.
