6. Committee apprised that to participate in tendering, bidder has to deposit tender fee in the form of DD for which dead line was 16.05.2023 in the office PIU-Chhatarpur (MP). However out of total participated 5 nos. of bidders, original DD of only 2 bidder (at Sl. No. 1 & 2 of para-5) was received by this office on 16.05.2023. To promote bigger participation in tender, committee decided to give 2 more days for receiving DD i.e. till 18.05.2023 and this information was shared to bidder via mail as well as telephonic communication. Committee further apprised that till 18.05.2023, DD of bidder at Sl. No. 3 & 5 of para-5 has also been received. However, as the DD in physical form of K.L. Enterprises has not been received till 18.05.2023 therefore committee recommended to reject the bid submitted by K.L. Enterprises.

7. Committee proceeded for technical evaluation of remaining 04 nos. of Bids out of 05 nos. bids received online on e-tender portal. Committee observed that all the 04 nos. of bidders found technically responsive for opening of financial bid and the statement of technical evaluation is as under:-
