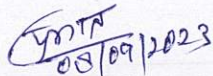


committee and committee has evaluated the bid as per the criteria specified in the bid document and the details are annexed in the statement.

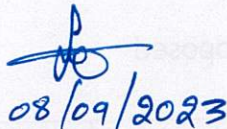
