The Committee met on 07.08.2023 at schedule time to open the Financial Bid of technically responsive Bidders'. No Bidder's representative attended the same (Annex-I).

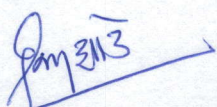
2. The Committee opened the financial bids and the summary Statement of Offer quoted by the Bidders is furnished below:

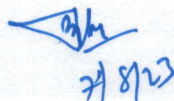

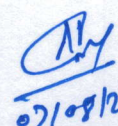
* The Bidder has quoted their offer in figures – **Rs.1,17,500/-**, whereas they have mentioned in words “**ONE LAKH SEVENTY THOUSAND FIVE HUNDRED**”.

The Clause – 10, 28 and Annexure-VI of Bid Document states that “The bidder shall quote rates / prices (both in figures and words) in the financial document. In case of discrepancy of amount in words & figures, the amount in words shall prevail”. Hence, the Committee considered the quoted offer of **Rs.1,70,500/-**, which is mentioned in words in the Financial Bid.

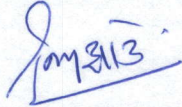
3. M/s. Rigid Manufacturing and Marketing Private Limited has quoted a highest offer of Rs.1,70,500/- (Rupees One lakh seventy thousand and five hundred only) per month for the subjected Highway Nest Mini for RHS & LHS (Both side).
4. In view of the above, Committee recommended that the subjected work may be awarded to H1 Bidder, M/s. Rigid Manufacturing and Marketing Private Limited with a quoted offer of Rs.1,70,500/- (Rupees One lakh seventy thousand and five hundred only) per month for the subjected Highway Nest Mini for RHS & LHS (Both side).

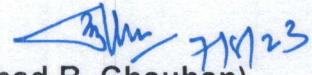

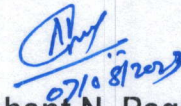
