This is with reference to your bid dated 02.08.2023 for the subject work. The results with respect to Technical Evaluation as approved by the Competent Authority is as under:

- The bidder M/s Janak N Panchal has failed to meet the eligibility criterion as per the clause 2.2.2.2 (iii) (a1) of Section 2 of RFP " (at least one similar Major Bridge/ROB/Flyover project in the last 10 (Ten) financial years preceding the Bid Due Date having span equal to or greater than 50% of the longest span or 100 m whichever is less of the structure proposed in this project having cost at least 20% of Estimated Project Cost of this project)". Accordingly, the bid of M/s Janak N Panchal has been considered Non-Responsive.
- The bidder M/s Shree Guru Infracon Pvt Ltd has failed to meet the eligibility criterion as per the clause 2.2.2.2 (i) of Section 2 of RFP. Accordingly, the bid of M/s Shree Guru Infracon Pvt Ltd has been considered Non-Responsive.
