With reference to NHAI's Request for Proposal for the subject project and considering your proposal in this regard, NHAI hereby accepts your proposal quoting Bid Project Cost of **Rs. 549.00 Cr (Rupees Five Hundred Forty Nine Crores Only)** and declares you as the "Selected Bidder" in terms of clause 1.2.7 & 3.8.1 of RFP.

2. In accordance with the clause 3.8.4 of the RFP document, you are requested to sign the duplicate copy of the LOA and return the same as your acknowledgement within 7 (Seven) days of the receipt of the LOA. Thereafter, you are required to execute the Concession Agreement within 45 (Forty five) days from the date of issue of LOA as specified in Clause 1.3 of RFP and Recital (D) of draft Concession Agreement.

3. Further, as per RFP documents, you are required to promote and incorporate a Special Purpose Vehicle solely for the purpose of implementing the project (the "Concessionaire") as a Limited Liability company under Companies Act 2013, as the entity which shall undertake and perform the obligations and exercise the rights of the Selected Bidder under the LOA, including the obligation to enter into the Concession Agreement pursuant to the LOA for undertaking the Project pursuant to Recital (E) of Draft Concession Agreement.

4. The Concessionaire shall, for the performance of its obligations under the Concession Agreement, provide to the Authority no later than 30 (thirty) days from the date of the Agreement, an irrevocable and unconditional guarantee from a Bank for an amount of **Rs. 16,47,00,000/- (Rupees Sixteen Crores Forty Seven Lakhs only)** equivalent to 3 (three) percent of Bid Project Cost quoted by you in the form set forth in Schedule-F (the "Performance Security") pursuant to Clause 9.1.1 of draft Concession Agreement.

5. You are required to comply with the above and all the terms and conditions set forth in the RFP documents and subsequent addendums/corrigendum issued. In case of any default on your part, you shall be liable for action as stated in the RFP Document.
