The bids for the subject project were invited vide NIT dated 14.06.2023 and total three bids were received within due date & time. The detailed evaluation of Technical Bids has been done and the result is as under:

Niroop Constro Ventures	Technically Non-Responsive	In respect of similar work submitted by bidder towards "Improvement to Phaltan, Pusegaon, Aundh, Gopuj, Nimsod Mhasume SH-147 from Km.0.00 to Km.47.00 under Maharashtra Road Improvement Programme", clarification was sought vide letter dated 22.08.2023 that whether the stretch is 4/6 lane or not. However, no clarification regarding 4/6 lane has been submitted by the bidder within 7 days of seeking clarification. As such this work cannot be considered under similar work category. To qualify for award of work as per RFP, the bidder shall have one similar completed work costing not less than amount equals to Rs.7.48 Cr or two similar works costing not less than Rs.4.68 Cr. Hence, the bid is not qualified for award of Contract as per clause 4.4 (A) (b) of Section II of RFP and shall be treated as Non-Responsive.
