This is with reference to your bid dated 27.07.2023 for the subject work. The results with respect to Technical Evaluation as approved by the Competent Authority is as under:

- The bidders M/s Ascent Electrification Engineers and M/s Current Infraprojects Private Limited, in their technical bids, have submitted that proof of Tender fee that was submitted by them for the Tender invited on 24.06.2023 with Tender ID 2023_NHAI_158755_1. Since the tender fee is non-refundable, tender submitted for the previous tender is not accepted for the instant tender with tender ID 2023_NHAI_158755_2. Accordingly, the bids of M/s Ascent Electrification Engineers and M/s Current Infraprojects Private Limited have been considered Non-Responsive.
- The bidder M/s Radadiya Paresh K did not meet the required Bid Capacity of Rs. 7.808 cr as per the clause 4.6 of Section-II of RFP. Accordingly, the bid of M/s Radadiya Paresh has been considered Non-Responsive.
- The remaining three bidders are found to be technically responsive. A summary of results of evaluation of technical bids is tabulated hereunder:

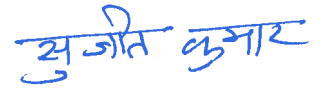
