CONTRACT AGREEMENT

This agreement made on the 08th day of November, 2023 between the National Highways Authority of India (NHAI), 2nd & 3rd Floor, Vijay Krishna Plaza, No.1, Lake Area, Melur Main Road, Mattuthavani, Madurai - 625 107 (herein after called "the Employer") of the one part and M/s V.Rasappan and Co., 103-B, Parry Nagar, Chinnandan Kovil Road, Karur - 639 002 (herein after called "the Contractor") of the other part.

AND WHEREAS the Employer invited bids from eligible bidders for the execution of "Construction of Service road on both sides of ROB approach near Boothipuram (from Km 74+400 to Km 75+118 on Dindigul side & from Km 75+450 to Km 75+900 on Theni side), Construction of RCC lined drain on BHS of Boothipuram cross road, Construction of RCC Retaining wall/toe wall, Widening of Culverts, etc., in Dindigul - Theni Section of NH-183 (Old NH-45E) in the State of Tamil Nadu on item rate basis".

AND WHEREAS pursuant to the bid submitted by the Contractor, vide Bid ID: 591666 on 09.08.2023 (herein after referred to as the "BID" or "OFFER") for the execution of

works, the employer by his letter of acceptance vide Letter No. NHAI/17011/01/73/2023/RO Madurai/E-212490/1982 dated 19.10.2023 accepted the offer submitted by the Contractor for the execution and completion of such works and remedying of any defects thereon, on terms and conditions in accordance with the documents listed in para-2 below.

AND WHEREAS the Contractor by a deed of undertaking dated 17.07.2023 has agreed to abide by all the terms of the bid, including but not limited to the amount of **Rs.9,49,74,509/- (Rupees Nine Crore Forty Nine Lakh Seventy Four Thousand Five Hundred and Nine only) (excluding GST)** quoted for the execution of Contract, as stated in the bid, and also to comply with such terms and conditions as may be required from time to time.

AND WHEREAS the contractor has agreed to undertake such works and has furnished a performance security amounting to **Rs.28,49,235/- (Rupees Twenty Eight Lakh Forty Nine Thousand Two Hundred and Thirty Five Only)** and additional performance security amounting to **Rs.28,49,235/- (Rupees Twenty Eight Lakh Forty Nine Thousand Two Hundred and Thirty Five Only)** for the unbalanced quote in pursuant to clause 33 of the instructions to bidders (Section-II).

NOW THIS AGREEMENT WITNESSETH as follows:

1. In this agreement words and expressions shall have the same meaning as are respectively assigned to them in the conditions of contract hereinafter referred to;
2. The following documents shall be deemed to form and be read and construed as part of this agreement viz.,
 - (a) Agreement,
 - (b) Letter of Acceptance,
 - (c) Contractor's Bid including Financial Bid Form,
 - (d) Contract Data,
 - (e) Conditions of Contract,
 - (f) Technical Specifications,
 - (g) Drawings if any,
 - (h) Implementation Manual and Maintenance Intervention Level
 - (i) Scope of work,
 - (j) Bill of Quantities and
 - (k) Any other document listed in the Contract Data.
3. The foregoing documents shall be construed as complementary and mutually explanatory one with another. Should any ambiguity or discrepancy be noted then the order of precedence of these documents shall be subject to the order as listed above and interpreted in the above order of priority.

The Employer hereby covenants to pay the contractor in consideration of the execution and completion of the works and remedying of defects therein, the contract price or such other sum as may become payable under the provisions of contract at the times and in the manner prescribed by the contract.
