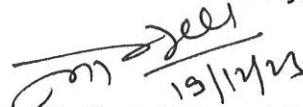

Bidder M/s Reliance Infrastructure Limited has submitted Bank Guarantee bearing BG no. APBBG29923NHA dated 29-09-2023 for bid security amounting to Rs. 5.26 Cr. issued by Asia Pacific Bank which has been advised by Bank of Baroda, Patipukur Branch, Kolkata as per para 14 of aforementioned Bank Guarantee. ii. As per provision of 2.20.1 of RFP, the Bank Guarantee shall be transmitted through

		SFMS Gateway to NHAI's Bank. However, Bank Guarantee bearing BG no. APBBG29923NHA has not been transmitted through SFMS Gateway to NHAI's Bank. iii. Afterwards, Bank of Baroda, Patipukur Branch was contacted for physical confirmation of said BG. In reply Bank of Baroda, Patipukur Branch stated that <i>"They have only advised the Bank Guarantee No.- APBBG29923NHA without any risk and responsibility from their part (as bank of Baroda). However, amendment copy is not uploaded in their system."</i> iv. Since, the Bank Guarantee bearing BG no. APBBG29923NHA for bid security could not be transmitted through SFMS portal to NHAI's Bank, the bidder stands TECHNICALLY NON- RESPONSIVE in line with the provision of 2.20.1 of RFP due to non-confirmation of Bank guarantee.
