OFFICE ORDER

Sub: NHAI, PIU, Rajamahendravaram - Providing Solar Highway Lighting at various Black Spot locations in all the Four (4) Packages of TOT Stretch between Anakapalli - Annavaram - Diwancheruvu section of NH-16 and Diwancheruvu - Siddhantham - Gundugolanu section of NH 216A under Road safety (4th call) - **Constitution of Committee for Evaluation of Tenders-Reg.**

In accordance with the Policy Guidelines issued by the Competent Authority vide reference 1st cited, and as per the instructions issued by the Regional Officer, NHAI Vijayawada vide reference 2nd cited, it is proposed to take up Solar Highway lighting towards short-term Corrective measures at 18 nos of blackspot locations in all the Four (4) Packages of TOT Stretch between Anakapalli - Annavaram - Diwancheruvu section of NH-16 and Diwancheruvu - Siddhantham - Gundugolanu section of NH 216A, at an estimated Cost of Rs. 2.44 Crs.

Accordingly, the draft RFP for the Proposed work was prepared as per Standard Request for Proposal (RFP) for National Highways and Centrally Sponsored Road Works proposed to be implemented on EPC Mode of Contract dated 05.03.2019 and subsequent amendments for calling of Tenders. Bids (4th Call) were invited on 08.08.2023 and the due date of receipt of bids is upto 16.00 hrs on 29.08.2023. The date and time of Opening of bids is 16.30 hrs on 30.08.2023.
