

Minutes of Tender Opening (Technical Bid)

Name of tender: Engaging an agency for providing vehicles on monthly hire basis to the officials of PIU-Kozhikode (2nd call)

Date&Time of technical bid opening: 24.08.2023 at 12.30 hrs

With the approval of Competent Authority (Note No.# 49 of E-office No.38931), an online tender for "engaging an agency for providing vehicles on monthly hire basis to the officials of PIU-Kozhikode (1st call)" was invited through e-tender portal as given under: -

- Availability of bids : 13.07.2023 (11.00 hrs) to 28.07.2023 (11.30 hrs)
- Bid submission date : 28.07.2023 (11.30 hrs)
- Tender/bid opening date : 29.07.2023 (12.30 hrs)

2. The tender committee, constituted as per Office Order No.28011/NHAI/PIU-KKD/Vehicle/2023/1244 dated 20.07.2023, had opened the tender physically/online at 12.30 hrs on 29.07.2023 and noticed that no bids were received in the e-tender portal. Hence, the tender committee had decided to invite 2nd call for the above-mentioned subject tender.

3. Subsequently, 2nd call was invited through e-tender portal as given under: -
- Availability of bids : 08.08.2023 (11.00 hrs) to 23.08.2023 (11.30 hrs)
 - Bid submission date : 23.08.2023 (11.30 hrs)
 - Tender/bid opening date : 24.08.2023 (12.30 hrs)

4. The tender committee has opened the tender physically/online on 24.08.2023 and found that three bids were received in the e-tender portal and accordingly the technical bids were downloaded for evaluation. The details of bidders are given below: -

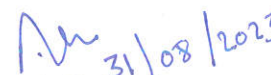
5. The technical evaluation has been carried out by the tender committee and the details of eligibility / qualifying criteria are mentioned in Annexure-1. The tender committee has found that the above three bidders are technically qualified for opening of financial bids.

6. The tender committee observed that M/s.ANM Tours & Travels Pvt. Ltd. has attached the signed copy of DD of Rs.50,000/- towards EMD in the e-tender portal, but not submitted the original DD physically. Hence the tender committee decided that M/s.ANM Tours & Travels Pvt. Ltd. may be intimated to submit the original DD within 3-days. The tender committee further decided that the financial bids of above three bidders may be opened after receipt of original DD from M/s.ANM Tours & Travels Pvt. Ltd.
