This has reference to your technical and financial proposal submitted on 11.09.2023 for the above mentioned project.

2. The Competent Authority has accepted your quoted financial proposal for a contract price of 16,80,28,000/- (Rupees Sixteen Crore Eighty Lakhs Twenty Eight Thousand Only) **excluding GST**.

3. The above contract price is exclusive of GST but inclusive of all taxes, duties, fees, levies and other imposition as may be levied under the Applicable law and NHAI shall deduct taxes as applicable, out of the eligible payments to be made to the Consultant. The amount towards GST shall be paid by NHAI separately on reimbursement basis, after submission of proof of depositing the same with the concerned Authorities by the consultant.

It is also requested to furnish within 15 days of issue this Letter of Award (LoA), an unconditional Bank Guarantee from Nationalized Bank as per details mentioned in RFP for an amount equivalent to 3% of the Total Contract Value i.e. Rs. 50,40,840/- (Rupees Fifty Lakh Forty Thousand Eight Hundred Forty Only) towards Performance Security. This Bank Guarantee shall be as per the format given in the RFP. The Performance Security shall be valid for a period of 92 months i.e. up to 2 months beyond the expiry of the Contract period of 90 months and shall be in the format specified in RFP. This Bank Guarantee shall be transmitted through SFMS Gateway to NHAI's Bank.
