

Sub- Hiring of One (01) No. Vehicle, (Scorpio or equivalent category vehicle), on monthly basis at NHAI - PIU Shillong- Reg.

PUC is reference of Quotation No. NHAI/PIU/SHL/2018/HOU/Vol-II/11551 dated 05.09.2023 for engagement of One Scorpio or equivalent category vehicle (travel up to 3000 km per month) as per terms & conditions, to be used by Manager(Tech) for official purposes.

Moreover, it is pertinent to mention that, this office had finalised the engagement of two nos. of vehicles (Bolero or equivalent category & Scorpio or equivalent category) in reference to Tender ID- 2023_NHAI_151518_1 and M/s ALF Hr Placement Consultancy services, Shillong entered into Agreement dated 01.06.2023 & dated 30.06.2023 to provide Scorpio or equivalent category & Bolero or equivalent category respectively. Accordingly, two numbers of vehicle was engaged by PIU-Shillong at an amount of Rs. 77,000/- for Scorpio and Rs. 72,000/- for Bolero at monthly basis.

Further, due to non-professional conduct, inadequate maintenance services, and non-reporting of vehicle on time, this office vide letter no. 11513 dated 21.08.2023 has issued advance notice as para 12 of agreement by stating the issues like Fuel provision issues, lack of communication & resolution, inaccessibility etc. However, M/s ALF Hr Placement Consultancy services was failed to provide adequate services and this office vide letter no. 11546 dated 04.09.2023 issued notice to discontinue the services to provided two numbers of vehicles.

The reasons as stated above, tender for engagement of one Scorpio or equivalent category vehicle was floated having Tender ID-**2023_NHAI_166800_1**

Four numbers of bidders has participated against floated on e-tender (Tender ID- 2023_NHAI_166800_1) has been received after opening of technical bid on 20.09.2023 and participated firm/Individuals as below:-

2. YVG Organisation
3. KL Enterprise
4. Himashree Das

The Technical bid was opened on 20.09.2023 and the same has been evaluated/checked by Committee members Sh. Biswa Jyoti Lahkar Manager (Tech) PIU Shillong & Sh. Kalyan Dutta Manager Tech PIU-Bongaigaon, where out of four participants, three participants was found responsive and Technical evaluation sheet is also attached herewith for ready reference.

As Three participants is responsive, hence for financial evaluation of the Quotation received from the firms a committee was formed. The committee members are-
