The tender for the work of "URGENT REPAIR OF PILE FOUNDATION IN MAJOR BRIDGE AT KM 19+400 ACROSS THENPENNAI RIVER IN VIKRAVANDI - SETHIYATHOPE SECTION OF NH - 45C IN THE STATE OF TAMILNADU (3rd call)" (Tender ID: 2023_NHAI_168992_1) was invited on 27.09.2023 under Two Cover System by the Project director, NHAI, PIU Thanjavur through online and last date for submission of bid and receipt of physical form was 13.10.2023. The date of opening of technical bids was 14.10.2023.

G.ILANGUMARAN, Tamilnadu (Bid ID: 615146) has not furnished the physical form of bid as well as documents regarding remittance of EMD and cost of tender documents. Also, the bidder has not completed similar nature of works in the SH/NH roads.

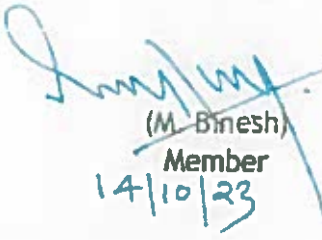
