NHA, PIU-Karaikudi invited bids vide Tender ID: ID:2023_NHA_169935_1 for the works of "Providing high mast and Solar blinkers in Junctions / Accident spot locations in Trichy - Karaikudi section of NH210 (New NH No.36, 336 & 536) from Km.10/000 to Km.91/054 including Trichy Bypass section of NH67 (Km.110/016 to Km.135/930) in the State of Tamil Nadu on Item Rate Basis" with an estimated cost of Rs.32.08 Lakh (excluding GST).

2. A committee has been constituted with the following members to carry out tender evaluation;

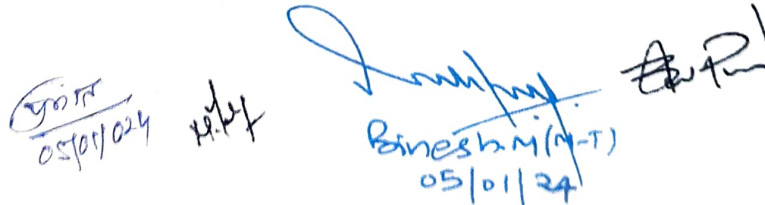

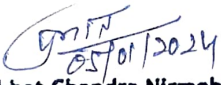
4. Subsequent to approval of Tender committee, the technical evaluation was uploaded in Government e-tender portal on 14.12.2023.

5. Committee have decrypted the financial bids submitted by technically qualified bidders on 22.12.2023 and amounts quoted by them are as under;

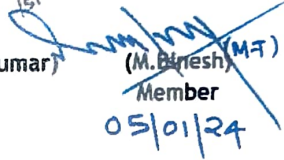
