Minutes of Meeting of Tender Evaluation Committee (Technical Evaluation) dated 11.12.2023 for the work of "Providing high mast and Solar blinkers in Junctions / Accident spot locations in Trichy - Karaikudi section of NH210 (New NH No. 36, 336 & 536) from Km.10/000 to Km.91/054 including Trichy Bypass section of NH67 (Km.110/016 to Km.135/930) in the State of Tamil Nadu on Item Rate Basis (Tender Ref. No. NHAI/PD/KKDI/Tender/01/2023).

1. NHAI, PIU-Karaikudi invited bids vide Tender ID: ID:2023_NHAI_169935_1 for the works of "Providing high mast and Solar blinkers in Junctions / Accident spot locations in Trichy - Karaikudi section of NH210 (New NH No.36, 336 & 536) from Km.10/000 to Km.91/054 including Trichy Bypass section of NH67 (Km.110/016 to Km.135/930) in the State of Tamil Nadu on Item Rate Basis" with an estimated cost of Rs.32.08 Lakh (excluding GST).

2. A committee has been constituted with the following members to carry out tender evaluation;

3. Last Date of submission of bids and Technical bid opening was scheduled on 06th and 07th November 2023 respectively.

4. As per MoRTH Circular No.RW/NH-37010/4/2010-EAP (Printing) Vol.IV Dated 30.04.2020, evaluation of bids has been carried out with the available documents uploaded in the portal as per RFP requirement.

5. Accordingly, the Committee have opened the e-bids submitted through online and decrypted. Totally 4 Nos. of Bids were received through online. The details of bids received and Financial Instruments submitted by bidders were furnished to Accounts Division. In response, Accounts Division has confirmed the receipt of bid document cost towards bid document fee and Bid Security.

6. Subsequently, the Committee has admitted & evaluated the 4 Nos. of bids based on the documents uploaded in portal and the detailed technical evaluation is furnished vide Annexure-A. Summary of the same is as follows:

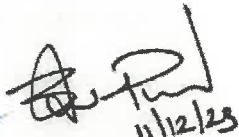

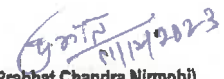

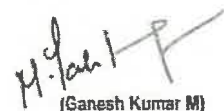
