

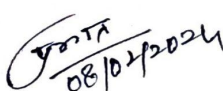

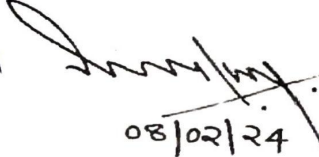

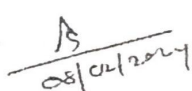
1. NHAI, PIU-Karaikudi invited bids vide Tender ID: ID:2023_NHAI_170431_1 for the works of "Providing high mast and Solar blinkers in Junctions / Accident spot locations in Karaikudi - Ramanathapuram section of NH 210 (New NH No.536) from Km.94/000 to Km.174/000 in the State of Tamil Nadu on Item Rate Basis" with an estimated cost of Rs.50.44 Lakh (excluding GST).

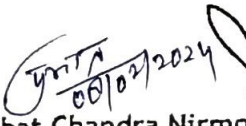

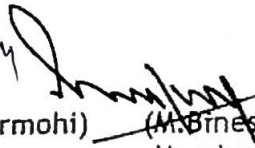

6. Committee have decrypted the financial bids submitted by technically qualified bidders on 06.02.2024 and amounts quoted by them are as under;

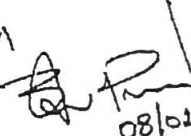

7. The Committee has evaluated the financial bids and recommends to award the instant tender works to the lowest bidder, M/s EKK Infra, Ernakulam for an amount of Rs.30,60,680/- @ 39.33% Less (Excluding GST). Further, committee has also recommended to obtain performance security @ 3% of Bid price & additional performance security @ 3 % of Bid price as per NHAI policy circular dated 13.09.2022, since the amount quoted by L1 bidder is lower than 35% of the estimated cost.
