- 3.0 The Clause-1.2.4 of RFP Document states that "The RFP is open to all the empanelled consultants who may apply for only those projects in which they do not find or anticipate conflict of interest as defined in this RFP. However, if a bidder applies for DPR Consultancy, Independent/Authority Engineer and Safety Auditor, the project awarded first shall prevail. Each team of two key personnel and one Sub Key Personnel of a firm shall not be eligible for award of more than **six Contract Packages** at any point of time. Further, firms empanelled for more than one team shall be eligible for award of multiple no. of packages depending on the no. of empanelled teams. However, a firm shall also not be allowed to propose more than one team for the same Project Package".

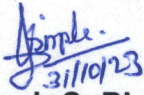

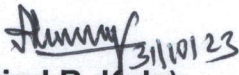

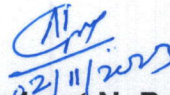
