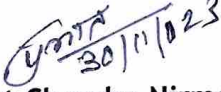

Name of Work: Providing, running & maintenance of vehicles on monthly hire basis for PIU Ramanathapuram.

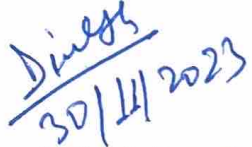

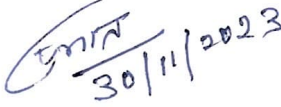
