Your Bid quoting remittance of Rs. 88,48,48,330/- (Rupees Eighty Eight Crore Forty Eight Lakh Forty Eight Thousand Three Hundred and Thirty only) for one (01) year for engaging you as the contractor for collection of user fee at above mentioned fee plaza, has been accepted by the competent authority of the NHAI on the terms and conditions of Contract forming part of the Bidding Documents.

- As per Clause 2.10.1 of RFP, within 7 (Seven) days from the date of issue of this LOA, you are required to submit a Performance Security consisting of (a) a crossed account payee demand draft/Pay Order, amounting to Rs. 3,62,65,000/- (Rupees Three Crore Sixty Two Lakh and Sixty Five Thousand Only) and (b) a bank guarantee valid for a period of 14 (Fourteen) months from the Date of LOA, in the prescribed format for to Rs. 3,62,65,000/- (Rupees Three Crore Sixty Two Lakh and Sixty Five Thousand Only).
- The Bid Security of Rs. 93.95 Lakh shall be forfeited by the Authority in case you fail to furnish the required Performance Security within the specified period, out of common bid security (BG) available with the Authority. As per Clause 3.6 of RFP, you shall also be required to sign the contract within Three (03) days from the date of submission of the Performance Security, take over the toll plaza and start the user fee collection within Two (02) days of signing the contract agreement and on failure to do so, the entire Performance Security including the bank guarantee is liable to be forfeited and invoked.
- In the event of your failure to submit the Performance Security, the Letter of Acceptance for award of contract in your favour shall automatically be terminated without further notice. In such a case, your engagement shall forthwith automatically stand terminated and thereupon, without prejudice to any other rights and remedies available to the Authority and the Authority shall be entitled to appoint another Contractor at your risk and costs and consequences.
