The tender for the work of "Operation and Maintenance of Nagercoil to Kavalkinaru section from km 0/0 to km 16/276 of NH-944 (Old NH-47B) for a period of 6 Months. (Tender ID: 2023\_NHAI\_175329\_1)" was invited on 22.11.2023 under Two Cover System by the Project Director, NHAI, PIU, Nagercoil through E-Procurement portal.

2. The last date for submission of bid and bid opening was proposed on 6<sup>th</sup> and 7<sup>th</sup> December 2023 respectively.
3. In this regard, 4 bids have been received through online within the scheduled period of Bid submission for the aforesaid tender, from the bidders namely, 1) M/s. KL Enterprises, Bangalore, 2) M/s. M. Muthukrishnan, Tirunelveli, 3) M/s. RR Associates, Guntur and 4) M/s. TTK Construction, Madurai.
4. Accordingly, the committee have confirmed the receipt of payment of tender processing fee for all the 4 bidders and received the confirmation of Bank Guarantee on 11.12.2023 towards BG furnished by M/s. KL Enterprises, Bangalore for EMD.
5. Accordingly, technical bid received from all bidders have been opened and evaluated as per the conditions of RFP. The evaluation of technical bid of all the bids is attached herewith.
6. It is observed that all the bidders have qualified in the technical bid evaluation and the committee unanimously decided to proceed for the financial bid evaluation.
