Minutes of the Tender Evaluation Committee meeting for the evaluation of Financial Bid for the work of "Urgent work of road marking from km 80+000 to km 128+480 RHS in the Thanjavur - Trichy Section of NH-67(New NH-83) in the State of Tamilnadu" (3rd call) (Tender ID: 2023_NHAI_176315_1) held in the (E-procurement portal) PIU, NHAI, THANJAVUR.

1. The tender for the work of "Urgent work of road marking from km 80+000 to km 128+480 RHS in the Thanjavur - Trichy Section of NH-67(New NH-83) in the State of Tamilnadu (3rd call)" (Tender ID: 2023_NHAI_176315_1) was invited on 01.12.2023 under Two Cover System by the Project director, NHAI, PIU Thanjavur through online and last date for submission of bid and receipt of physical form was 16.12.2023. The date of opening of technical bids was 16.12.2023.

2. Accordingly, the tenders received through online were opened by the Evaluation Committee on 16.12.2023. The details of bidders who submitted the bids through online form in e-tender portal are as under:

3. The accepted technical bids were evaluated by the evaluation committee on 16.12.2023 and the technical bids of the following 02 bidders were found as "Responsive":

4. Further, the financial bids of the above responsive bidders were opened on 04.01.2024 @ 11.00Hr. The Composition of the Financial Evaluation Committee is the same as Technical Evaluation Committee as below

4. The aforesaid evaluation committee has evaluated the financial bids on 04.01.2024. The details of the financial bids are as detailed below:

5. After Evaluating the Financial bids, the committee found that the bid of M/s. Muthuram Enterprises (645659) to Rs. 28,07,713.02/- working out to 64.08 % less than the amount put to tender i.e., Rs. 78,16,573/- is the lowest and Responsive bid.

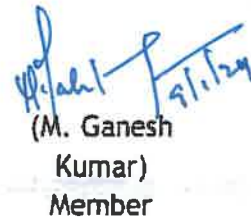
6. Further, the Financial Evaluation Committee decided to obtain justification for abnormally low quoted rates from the lowest bidder M/s. Muthuram Enterprises (645659), Erode on 04.01.2024.

7. The lowest bidder of M/s. Muthuram Enterprises (645659), vide letter dated 08.01.2024 furnished the justification for abnormally low quoted rates. The same has been examined by this committee. The bidder stated that they have some own machineries and effective labour force. The bidder also stated that they will get more discounts for materials.

8. In view of the justification along with rate analysis in support of the quoted price furnished by the L-1 bidder, the Committee recommends to award the instant tender work to the L-1 bidder M/s. Muthuram Enterprises (645659), Erode. Further, the Committee also recommend to obtain performance security @ 3% of bid price and additional performance security @ 3% of bid price as per NHAI Policy Circular No. 11.42/2022 dated 13.09.2023 citing the reasons that the L-1 bidder has quoted abnormally low bid price. The additional performance security shall be taken with the approval of the higher authority to the authority competent to finalize the particular tender and in this case RO, Madurai is having powers to approve collection of additional performance security.
