N. ii. **"Performance Security is to be furnished by a specific date and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the contractor, including Defect Liability Period (DLP) plus 1 (One) year of claim period beyond this duration."**
