Ref: Your E-Tender for the above contract at Agatti Airport.

Dear Sir,

The undersigned is pleased to convey the approval of Competent Authority for award of the license for the facility of **STAFF CANTEEN AT AGATTI AIRPORT** to **M/s.VIP Services , Bhopal** with the quoted Monthly License Fee of **Rs. 5100/-** (Rupees Five Thousand One Hundred only) per month, plus applicable GST and other charges as applicable from time to time compounded with 10% annual escalation, for a period of 2 years extendable by one more year for an area measuring 36.83Sq. mtr in Agatti Airport subject to the NIT conditions and the following terms & conditions.

1.	License	License to operate Staff Canteen at Agatti Airport
2.	Period	02 Years extendable by another one year
3.	Area / Location	36.83 sq. mtr in Airport Complex,
4.	License fee	Rs.5,100/- pm + GST and other applicable charges. License fee should be paid on or before 25 th of every month in advance. The tax (GST) is applicable @ 18% subject to revision as per Govt. Directive.

5.	Electricity & Water Charges	As per EB tariff /water charges on actual consumption of electricity and water charges as per the rates charged by State Govt. on actual basis. The rates are subject to revision from time to time.
6.	Utility / Facilitation Charges	Not applicable
7.	Advance License fee	License fee - Rs.5100/- GST @ 18% - Rs. 918/- Totally Rs. 6018/- (Rupees Six thousand and eighteen only) shall be paid online to the bank account of AAI, SR, Chennai
8.	Security Deposit for License Fee	Equivalent to Four Months of license fee of 1 st year amounting to Rs. 20,400/- (Twenty Thousand Four Hundred only) shall be paid online to the bank account of AAI, SR, Chennai / Bank guarantee from any Nationalized Bank except Co-operative Banks, subject to NIT conditions.
9.	Security Deposit for Electricity charges/water charges	An amount of Rs.10,000/- (Rupees Ten Thousand only) towards Security Deposit for Electricity and water charges shall be paid online to the bank account of AAI, SR, Chennai.
10	Rate of Escalation	Annual escalation of 10% with first annual escalation to be effective on completion of 18 months licence which is to be reckoned from the original date of commencement of contract.
11.	Agreement	An agreement in duplicate in the prescribed format as per NIT is to be executed on non-judicial stamp paper of the value of Rs.100/-. Cost of Stamp Paper shall be borne by you. This award letter shall also form part of the Agreement.
12	Infrastructure and maintenance	The infrastructure for canteen such as tables and chairs shall be provided by the licensee.
13	Display of Licensee name/Advertisement etc.	a) Display of name and logo of the agency operating staff canteen is permissible on the front elevation. The maximum size of signboard should not exceed the maximum facia of 12 sq.ft.

		b) No other advertisement, hoarding, banners are permitted to be erected or displayed at the allotted space or at any other place in the office premises/airport other than that indicated above. c) Any other form of advertisement, viz. advt. on disposal cups, plates, packing boxes, tissue papers etc. are not permitted
14.	Usage of canteen kitchen	Licensee shall not use kitchen to supply food outside.

Other terms and conditions:

01. After taking over the License, if the License fee and other applicable charges, as per bill, is not paid within the stipulated date, penal *interest @ 9% per annum shall be charged from the due date for delayed period up to 30 days and if delay is for more than 30 days, then interest @ 18% per annum shall be charged from the due date for entire delay period be payable on all delayed payment*, without prejudice to the Authority's other rights and remedies. Besides, action as deemed necessary will be taken as per the Agreement conditions under the rules and in addition the administrative cost of re-tendering will be deducted from the Security Deposit.

02. That the license for the above said facility shall be valid for the period of **02 Years with effect from the date of taking over of license,**

extendable by one year unless terminated earlier on account of following:

- (a) By giving **30** days' notice in writing from either side without assigning any reason.
- (b) Terminated by AAI on a short notice on account of un-satisfactory performance.
- (c) Termination on expiry of the specified time period allotted for unresolved internal dispute resolution.

03. Penal action, as appropriate, would be initiated on account of unsatisfactory performance such as: (i) Delayed payment of License fee (ii) Non-observance of approved rates of items (iii) Not maintaining the quality in providing service/facility (vi) Rate list (v) Any other breach in the terms and conditions of license agreement including notice period for terminating license etc.

04. In case of failure to accept the terms and conditions of the award of license, you will be debarred from participating in any Commercial License/Tender at AAI, at any Airport, for a period of 01 year.

05. *The EMD will be forfeited and the party may be debarred for further participation in AAI's tender(s) for a period of 01 year on account of non-compliance of the following: -*

(a) Acceptance of the offer **with in 07 days** from the date of issuance of this award letter.

(b) Payment of advance license fee for one month **within 15 days** from the date of issuance of the award letter.

(c) Payment of Security Deposit **within 15 days** from the date of issuance of award letter, amounting to 4 months equivalent concession of the First (1st) year to AAI as an interest free security Deposit. The SD amount equivalent to 2 months concession fee to be submitted in the form of BG from any scheduled commercial bank (Bank Guarantee from co-operative bank, even scheduled, will not be accepted) and balance 2 months equivalent concession fee by way of NEFT/RTGS or DD/PO.

(d) Execution of the Agreement within 15 days from the date of issuance of award letter (on stamp paper of appropriate value, related costs to be borne by the licensee).



(e) Commencement of the facility within the applicable gestation period as per NIT conditions.

06. The acceptance should be conveyed **within 7 days by** signing and returning the duplicate copy of the award letter. It is also requested that all the formalities related to submission of Bank Guarantee, advance payment of license fee as mentioned above, may please be completed within the stipulated time.

07. The licensee is liable to obtain proper insurance coverage for their properties / goods stored or used in the licensed premises.

08. The licensee shall obey the various Central and State Govt. Labour Laws in force from time to time and ensure their registration etc. as per rules.

09. The licensee shall abide by the rules & regulations and legislation of Central and State Government on Environmental protection applicable from time to time.

10. The licensee is liable to implement the AAI commitments and practices on ISO 14001 – 2004 (Environmental Management System).

11. Modification/renovation, if any required in the allotted area should have prior approval of the competent authority of AAI.

12. The licensee shall not unless with the written consent as afore said assign or transfer the present license or any party thereof.

13. The licensee shall abide by the terms and conditions, rules, and regulations of AAI as may be enforced from time to time.

14. In addition, all rates, assessments, outgoings and other taxes wherever applicable including the service in respect of the said premises will be payable by the licensee.

15. The licensee shall use the area only for the purpose for which it is allotted and for no other purposes and confine their activities within the space allotted.

16. The allotment is subject to clearance of all outstanding dues, if any.

17. The award letter & e-tender NIT shall form part and parcel of the agreement.

18. The allotment of subject space can be cancelled at short notice if the space required by AAI for expansion/modification of Airport and the licensee shall vacate the space without any protest or claims for compensation.

19. The counter shall be equipped with Dual Mode of electronic payment and BHIM App facility. Before commencement of construction the licensee has to obtain approval from RHQ-SR.

20. *You are requested to kindly complete the above cited formalities and take possession of the license before expiry of the gestation period, as per the NIT conditions.*
