You are directed to deposit Rs.1,79,380.00 (Rupees One lakh seventy nine thousand three hundred and eighty only) towards security deposit within 10 days from the date of issue of this letter, failing which, 10% of value of work done will be deducted from the running account bills as security deposit as per condition of Clause No.1(A) on page No. 37 of the Tender Document. The Earnest Money Amount of Rs. 44,000.00 (Rupees Forty four thousand only) received on line payment through CPP portal along with your tender will be refunded after your depositing of security deposit or after deduction of the EMD amount as security deposit from the running bills.
