2. In this context, we are glad to inform that the competent authority has accepted your offer and decided to award the subject License on the following Terms and Conditions:-

1.	Facility	License to smoking lounge and sales kiosk inside SHA at KBR Airport, Leh.				
2.	Location	Inside Terminal Building of KBR Airport, Leh.				
3.	Area	6.6 square meters (approx.) – 4.6 sqm for smoking lounge and 2 sqm for sales kiosk				
4.	Periodicity	01(One) Year OR shifting of operation to new terminal building, whichever is earlier. (a) The license can be terminated by giving 30 days' notice in writing from either side without assigning any reasons. (b) AAI can also terminate the license on a short notice of 15 days on account of unsatisfactory performance of the licensee.				
5.	Business Incubation period	15 days from the date of issuance of this award letter.				
6.	Gestation period	Gestation period of 120 days reckoned from the date of handover of physical possession of site to licensee or 16 th day from issuance of award of contract, whichever is earlier, shall be permissible. The licensee has to ensure all the compliances including requisite licenses for operation of the facility, security compliances and fabrication of counters etc. within the gestation period itself. Claim for additional gestation period or rebate on account of any non-compliance by the licensee within the gestation period shall not be entertained by AAI at any stage.

8.	Escalation	Escalation in license fee shall apply as per clause 4 of NIT.	
9.	Charges towards consumption of electricity and water	To be paid by the agency on actual consumption basis at the rate(s) notified by AAI from time to time.	
10.	Security Deposit	(i) Payment of Security Deposit equivalent to 03 months of License Fee (including taxes and other charges) of first year i.e. Rs. 2,69,121/- to AAI as an interest free security deposit. The SD is to be furnished in the form of Bank Guarantee only to be issued by Nationalized/Scheduled Bank having a validity of 180 days from the date expiry of Contract. BG from Cooperative Bank (even scheduled) or in the form of FDR is not acceptable. (ii) Payment of Security Deposit equal to 5 % of the annual License fee i.e. Rs. 53,824/- towards electricity/water/telephone/data port etc. in the form of RTGS/NEFT in favor of Airports Authority of India. This exercise of submission of SD is to be done within 15 days from the date of issuance of this Award Letter.	
11.	One-month advance License fee of Rs. 89,707/- , inclusive of GST is payable in the form of RTGS/NEFT in favor of Airport Authority of India within 15 days from the date of issue of this Award letter.		
12.	Agreement has to be executed on non-judicial stamp paper of Rs. 200/- within 15 days from the date of issuance of award letter. The cost of Stamp Paper(s) and related costs shall be borne by the licensee.

14.	Authority shall raise all bills (including MMG/MAG and any other bills except annual land lease bills) for the current month on 1st day of month in advance except true-up and reimbursement of expenditure bills like electricity, water etc. The invoice for the reimbursement of the expenditure like electricity, water charges etc. for the completed month shall raise on 5th of succeeding month. A credit period of 15 days (date on invoice plus 15 days) shall be provided, which is subject to reduction as and when decided by Authority. Authority shall levy panel interest @12% per annum from due date (i.e., date of invoice plus 15 days) till the actual date of payment received in Authority's account in the cases		

	concessionaire/ agencies settled the invoice after due date but within 90 days (date of invoice plus 90 days) and @18% per annum from the due date till the actual date of payment received in Authority's account in the case of concessionaire/ agencies settled the invoice after 90 days. In case of part payment made by any agency, same rate of interest on the balance amount of the invoice as applicable shall be charged.
15.	Joint measurement of the area offered under license, to be conducted by AAI and the authorized representative(s) of the licensee at the time of handing over / taking over of possession of site, which shall in any case not exceed beyond the prescribed period of handing/taking over of site(s). This Joint measurement along-with report on handing over / taking over of site shall form part of the agreement to be executed.
16.	Compliance of prevailing Security norms etc. from time to time shall be ensured by the licensee. For any information / clarification pertaining to prevailing Security norms and compliance thereof etc., you are advised to contact Security Department, AAI, Leh Airport and concerned Regional Director of Bureau of Civil Aviation Security (BCAS). Post acknowledgement of Award letter and before commencement of business, it is the responsibility of awardee to submit an application to BCAS through e-SHAJ portal of BCAS for Security Clearance of the licensee. A copy of the submitted application along with Security program has to be furnished thereafter to the Security Department, AAI Leh for approval of BCAS. For detailed information on this aspect, the Awardee should visit BCAS website and/or Office of concerned Regional Director, BCAS.
17.	That the Authority reserves to itself the right to change the location of the premises at any time and may at its discretion to call upon the Licensee to vacate the site and may give him an alternative premise for the purpose of this License. In such a case, the Licensee shall be bound to vacate the premises immediately and accept the said alternate premises. The entire expenditure on such shifting shall be borne by the licensee and the licensee shall not be entitled to claim any compensation or revision in the license fee on that score.
18.	AAI does not take any responsibility of providing any type of light fittings except light point, fan point, AC point for which wiring with metering already existing.
19.	You will have to make your own arrangements for providing the office furniture and other electrical gadgetries etc. subject to approval of drawings by AAI before taking up of any construction or modifications at the site.
20.	You shall not erect or display any type of advertisements or signboards except the name and logo of your license after obtaining the prior approval in writing from AAI.
21.	The acceptance of the above terms and conditions along with copy of this Award Letter (duly signed by the Licensee) must be forwarded to this office within seven (07) days of receipt of this LOIA. Further, the formalities listed at per para 10, 11 & 12 must be completed within the time lines specified therein.
22.	All other terms and conditions shall be as per e-NIT. This award letter shall form a part of the license agreement to be executed.
