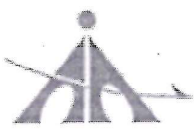

1. Your e-tender for the above mentioned work has been accepted by the Competent Authority on behalf of the Chairman, Airports Authority of India, at the item rates quoted by you totaling to ₹ 46,41,184.00 (Rupees Forty-Six Lakh Forty-One Thousand One Hundred and Eighty-Four Only) excluding GST which is 16.325% (Sixteen Decimal Three Two Five Percent) below the Estimated cost of ₹ 55,46,685.00 excluding GST put to tender. Out of the quoted amount of ₹ 46,41,184.00 an amount of ₹ 39,82,000.00 (Rupees Thirty-Nine Lakh Eighty-Two Thousand Only) is towards the work part of SITC of CCRs and 6,59,184.00 (Rupees Six Lakh Fifty-Nine Thousand One Hundred and Eighty-Four Only) is for CAMC of CCRs for 5 years after DLP of 2 years.
2. Joint General Manager (Engg-Elect.), AAI, Chennai Airport, Chennai - 600 016 shall be the Engineer-in-Charge of the work. You are requested to attend to the Office of Joint General Manager (Engg-Elect.), AAI, Chennai Airport by 09.08.2024 to sign and complete the contract agreement. The contract agreement shall be executed on a non-judicial stamp paper of value ₹ 100.00 (Rupees One Hundred only) and the cost of the stamp paper shall be borne by you.
3. Please deposit an amount of ₹ 4,64,118.00 (Rupees Four Lakh Sixty-Four Thousand One Hundred and Eighteen Only) towards Security Deposit within 10 days from the date of issue of this letter, failing which, the same will be deducted as per Clause 1A of Contract Document. Earnest Money Deposit amount will be returned back to your account after deducting equal amount of EMD against Security Deposit from your bill.
4. You are requested to comply with the provision of Contract Labour (Regulation and Abolition) Act 1970 and Contract Labour (Regulation and Abolition) Central Rules 1971 and Minimum Wages Act and Rules there of Central and State Governments.
5. Please note that the time allowed for carrying out the SITC work shall be 02 (Two Months) and the same shall be reckoned from 09.08.2024. The time allowed for CAMC is for a period of 5 years (after DLP of 2 years) which will be reckoned as per the actual date of Completion of work.
