2. Senior Manager (Engg-Civil), AAI, Imphal Airport, shall be the Engineer-in-charge of the work. You are requested to attend the office of Senior Manager (Engg-Civil), AAI, Imphal Airport by 09.09.2024 to sign and complete the contract agreement. The contract agreement shall be executed on a non-judicial stamp paper of value Rs.100 (Rupees One hundred only) and the cost of the stamp paper shall be borne by you.
3. The earnest money amount of Rs 1,40,000/- (Rupees One Lakh and Forty thousand only) received along with your tender will be treated and converted as part of Security deposit as per Clause No1(a) on page no: 16 of contract document. Please deposit Rs. 4,83,000 (Rupees Four Lakh forty three thousand) towards security deposit within 10 days from the date of issue of this letter failing which, the same will be deducted as per condition of Clause no1(a) at page no: 16 of the contract document.
4. You are requested to comply with the Provision of Contract Labour (Regulation and Abolition) Act 1970 and Contract Labour (Regulation and Abolition) Central Rules 1971 Child Labour (Prohibition & Regulation) Act 1986, Construction Workers (Regulation of Employment and Condition of Service) Act 1996, Building and other construction Workers Welfare Cess Act 1996 as specified in of GCC of tender and Rules of Central and State Government.
5. You are also directed to contact Senior Manager (Engg-Civil), AAI, Imphal Airport, immediately who will arrange to hand over the site to you.

6. Please note that the time allowed for carrying out the work shall be 12 (Twelve) months and same shall be reckoned from the 10<sup>th</sup> day after issue of this letter.
7. Any further correspondence in connection with the contract should normally be addressed to the Engineer-in-charge.

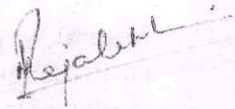
