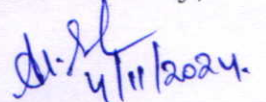

2. Sr. Manager (Engg-Civil), AAI, Salem Airport – 636309 shall be the Engineer-in-Charge of the work. You are requested to attend the office of the Sr. Manager (Engg-Civil), AAI, Salem Airport – 636309 within 10 days from the stipulated date of start of work to sign and complete the contract agreement. The contract agreement shall be executed on a non-judicial stamp paper of value of Rs. 100/- (Rupees One hundred only) and the cost of stamp paper shall be borne by you.
3. You are directed to deposit Rs. 2,62,500.00 (Rupees Two lakhs Sixty-Two thousand and five hundred only) towards security deposit within 10 days from the date of issue of this letter, failing which, 10% of value of work done will be deducted from the running account bills as security deposit as per condition of Clause No. 1(A) on page No. 16 of GCC of the Tender

Document. The Earnest Money Amount of Rs. 17,000 (Rupees Seventeen thousand only) received on line payment through CPP portal along with your tender will be refunded after depositing of security deposit or after deduction of the EMD amount as security deposit from the running bills.

4. You are requested to comply with the provisions of contract labour (Regulation and Abolition) Act 1970 and Contract labour (Regulation and Abolition) Central Rules 1971 and minimum wages Act and rules thereof Central and State Governments.
5. Necessary BCAS clearance to execute the work at Airport/obtaining Security/ Entry Passes has to be obtained through e-sahaj portal.
6. You are also directed to contact Senior Manager (Engg-Civil), AAI, Salem Airport immediately who will arrange to hand over the site to you.
7. Please note that the time allowed for carrying out the work shall be **12 (Twelve) Months** and same shall be reckoned from the tenth day after issue of this letter.
8. Any further correspondence in connection with the contract should normally be addressed to the Engineer-in-Charge.
9. Please acknowledge the receipt and return the duplicate copy of this letter enclosed herewith after signing it to the undersigned, as a token of acceptance.

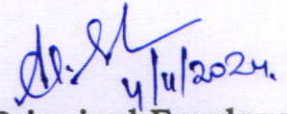
