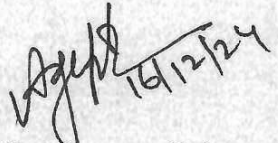

- 5) You are requested to complete the following as per the timeline mentioned:
- Convey your acceptance of terms and conditions of this LOIA and the NIT on a duly signed duplicate copy of this LOIA within 7 days from issue date of this letter and be ready to pay the advance license fee amount of Rs. **Rs. 4008.00 /-** (Per Month + Utility Charges + Applicable taxes through NEFT/RTGS of any nationalized/scheduled bank within 7 days from issue date of award letter.
 - Submit security deposit amount of **Rs. 12024/-** (Twelve thousand and twenty-four rupees Only) as Security Deposit in the form of Bank Guarantee of Nationalized/Scheduled Bank in favour of Airports Authority of India within 07 days from issue date award letter. Bank Guarantee from Co-operative Banks will not be accepted.
 - Submit the Agreement on non-judicial stamp paper of Rs.100/- for this contract as per details given in NIT. The agreement should be submitted in quadruplicate (01 original plus 03 photocopies). Signature of both the parties shall be original on all the copies. The cost of the stamp paper shall be borne by the licensee.
- 6) All terms and conditions of the license as per tender document shall be applicable.
