Please deposit **Rs 1,46,931.00/- (Rupees One Lacs Forty-Six Thousand Nine Hundred and Thirty-One Only)** towards Security Deposit within 10 days from the date of issue of this letter, failing which, the same will be Deducted as per Clause No.1(A) of General Condition of Contract document.
