Sir,

On the above cited subject, reference is made to E-Bid No. 2024_AAI_210558_1 published on 08/10/2024 and E-Financial Bid opened on 29/11/2024. The competent authority has accepted your offer and decided to award the subject License under the following Terms and Conditions:-

1. The period of license :- **Five years.**

2. Area :- **Smoking Lounge - 17.92 sq. mtr and sales kiosk - 02 sq. mtr.**

3. License fee for the first year shall be payable as under:-

(i) **Payment of License fee of Rs. 2,10,000/- (Rupees Two Lakh Ten Thousand Only) per month plus**

(ii) **Utility Facilitation/CAM Charges = Rs. 1,992/- (Rupees One Thousand Nine Hundred Ninety Two Only) per month plus**

(iii) **GST@18%=Rs. 38,159/- (Rupees Thirty Eight Thousand One Hundred Fifty Nine Only)**

4. In addition to above charges towards consumption of electricity and water as may be notified by the Authority and at the rate(s) notified from time to time, is payable.

5. **Annual escalation :-** Rate of annual escalation on the license fee shall be 10%.

6. License fee bill for the current month shall be raised on 1st day of month in advance. The invoices for reimbursement of expenditure like electricity, water charges etc. for the completed month shall be raised on 5th of succeeding month.

A credit period of 15 days (date of invoice plus 15 days) shall be provided. Further provision to be kept in all new agreements to reduce the credit period as and when decided by AAI.

AAI shall levy penal interest @ 12% per annum from the due date (i.e. date of invoice plus 15 days) till the actual date of payment received in AAI account in the cases concessionaire/agencies settled the invoice after due date but within 90 days (date of invoice plus 90 days) and @ 18% per annum from the due date till the actual date of payment received in AAI account in the case of concessionaire/agencies settled the invoices after 90 days. In case of part payment made by any agency, same rate of Interest on the balance amount of invoice as applicable shall be charged.

7. One month advance License fee of **Rs. 2,50,151/- (Rupees Two Lakh Fifty Thousand One Hundred Fifty One Only)**, inclusive of GST is payable in the form of RTGS/NEFT in favour

of Airports Authority of India payable at Prayagraj within 30 days from the date of issue of this Letter of Award.

8. (i) Payment of Security Deposit within 30 days from the date of issue of award letter equal to 06 (Six) months of Equivalent License Fee of first year i.e. **Rs. 15,00,906/- (Rupees Fifteen Lakhs Nine Hundred Six Only)** to AAI as an interest free security deposit. The SD shall be furnished in the form of Bank Guarantee only to be issued by Nationalized / Scheduled Bank. The Bank Guarantee should be valid for the entire period of license plus twelve (12) months from the date of expiry of License period. Bank Guarantee from Co-operative Banks, even scheduled co-operative banks/Societies /Payment Banks or by means of FDR, shall not be acceptable. Bank charges shall be borne by the agency.

(ii) Payment of Security Deposit towards Utilities (Electricity, Water, Data Port, Telephone etc.) equal to 5 % of the annual License fee for the first year i.e. **Rs. 1,26,000/- (Rupees One Lakh Twenty Six Thousand Only)** in the form of DD/PO/NEFT/RTGS/BG/VPA shall be deposited in favour of Airport Authority of India, Prayagraj Airport, Prayagraj within 30 days from the date of the issue of this Letter of Award.

Notes:-

i. No interest is payable on Security Deposit. The Bank Guarantee should be valid for the entire period of license plus twelve (12) months from the date of expiry of License period..
