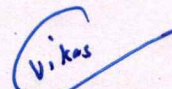

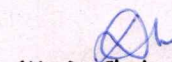

M/s Rahul Enterprises Ulhasnagar to submit work experience as the Tender Eligibility Criteria. 5. M/s Nikhil Sangolikar Ambernath, M/s Sunbud Multiventures Pvt Ltd Ambernath & M/s Rahul Enterprises Ulhasnagar have submitted required documents against EOC clarification dated mentioned above. 6. 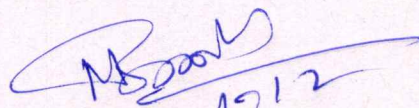
