Experience of having successfully completed similar type of works during last 07 years ending last day of month previous to the one in which applications are invited should be either of the following:

a)

Three similar works each costing not less than 40% of the estimated cost. (Rs. 113.86 Lakhs)

b)

Two similar works each costing not less than 50% of the estimated cost. (Rs. 142.33 Lakhs)

c)

One similar work costing not less than 80% of the estimated cost. (Rs. 227.73 Lakhs)

11.	Deliberation: 1. Total 06 Firms participated in the subject Tender by submitting scanned copy of required EMD as per details mentioned under SI No. 9 above. It is observed that M/s Kugan construction, Ambernath have not submitted the required EMD physically. Hence EO Civil vide email Dated 13-05-2024 requested M/s Kugan construction, Ambernath to submit required EMD physically on or before 14-05-2024. In reply Firm vide email Dtd. 14.05.2024 stated that Firm will not submit EMD physically as firm is doing many Tenders and not able to give sufficient time and man power to complete the work within PDC and hence withdrawing from Bid. 2. As per Tender Condition, participating Firms are required to upload sealed and signed Declaration on Firm's Letterhead w.r.t. the Tender Documents mentioning that the <u>'Firm has read & understood all the conditions mentioned on each page of Tender Document, Instruction to Bidders, Eligibility Criteria, Technical Specifications & all other conditions before quoting for tender'</u>. 3. It is observed that M/s Jaypee Enterprises, Bhandara have not submitted the required declaration. Hence EOC vide email Dtd. 04.05.2024 requested Firm to submit required sealed & signed declaration on Firm's letter head. In response, the Firm vide email Dtd. 04.05.2024 submitted required declaration on Firm's Letterhead. The Firm along with this mail also forwarded IT returns for last three Fin. Years. 4. The scrutiny of uploaded documents submitted by all the participating Firms in their Technical Bid is carried out as per Tender Eligibility Criteria conditions. It is observed that the documents uploaded by M/s Sunbud Multiventures Pvt Ltd, Ambernath, M/s Krishna Construction Co., Latur, M/s Jaypee Enterprises, Bhandara & M/s Kugan constructions, Ambernath are as per Tender Eligibility Criteria conditions and details are appended in SI No. 10 (A) & 10 (B) above. 5. However, during scrutiny of Technical Bid of M/s Shree Ayyappa Engg, Mumbai, it is observed that, Firm has not uploaded required completion certificates for similar completed works & also not uploaded required Turnover certificate. Hence EO Civil vide email Dtd. 04-05-2024 requested Firm to submit the required completion certificates & Turnover Certificate as per Eligibility Criteria. In response the Firm vide email Dtd. 04.05.2024 forwarded Three Completion certificates and the Turnover certificate. However it is noted that the completion certificates submitted by Firm do not suffice the Tender Eligibility Criteria conditions. Hence EOC vide email Dtd. 06.05.2024, once again requested Firm to submit the Completion Certificates as per Eligibility Criteria. In response the Firm vide email Dtd. 06.05.2024 submitted another Completion Certificate with completed value of work as per Eligibility Criteria. It is observed that the date of Completion of work is 30 Mar 2024, and as per Tender Condition the similar work shall be completed during last 7 years ending last day of the month previous to the one in which applications are invited. Hence the similar work shall be completed up to 31.01.2024 as the tender enquiry is floated on 17.02.2024. The details of work completion certificates submitted by Firm are mentioned in SI. 10 (A) above.

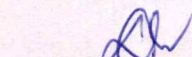
	6. Further During scrutiny of Technical Bid of M/s Dhanlaxmi Merchandise Pvt. Ltd. Bhopal, it is observed that, Firm has uploaded only one completion certificate for similar completed works. However it is noted that, the date of completion of work is 13.02.2024. As per Tender Condition the similar work shall be completed during last 7 years ending last day of the month previous to the one in which applications are invited. Hence the similar work shall be completed up to 31.01.2024 as the tender enquiry is floated on 17.02.2024. Hence EO Civil vide email Dtd. 15-05-2024 requested Firm to submit the completion certificates as per Tender Eligibility Criteria. In response the Firm vide email Dtd. 15.05.2024 intimated that the Firm has completed only one work till date. The details of work completion certificates submitted by Firm are mentioned in Sl. 10 (A) above.
12.	Decision:
	MTPF CWC-I (Fy) after detailed deliberations decided to open the Price Bids of only 03 Technically Eligible participated firms namely, 1. M/s Sunbud Multiventures Pvt Ltd, Ambernath. 2. M/s Krishna Construction Co., Latur. 3. M/s Jaypee Enterprises, Bhandara. The remaining Three Firms as given below are technically disqualified due to non-compliance of tender Eligibility Criteria. 1. M/s. Kugan constructions, Ambernath 2. M/s Dhanlaxmi Merchandise Private Limited, Bhopal MP 3. M/s Shree Ayyappa Engineering, Goregaon Mumbai
