CWC-I deliberated the case and observed that both the participating Contractors have fulfilled the eligibility conditions of the tender.

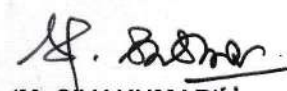
18 **DECISION OF CWC-I HELD ON 12-07-2024 :**
