First Tender(2024 AVNL 190292 1): CWC – I held on 31-05-2024 observed that efforts for Price revision was made and in reply the L1 Contractor has not reduced considerably and the revised percentage was higher than the estimated percentage by (+) 16.99 %. Hence CWC – I decided to cancel the tender and to re-tender the case.
Second Tender(2024 AVNL 197482 1): Since there was No Participation in the tender, Competent Authority approval was obtained and the case was Cancelled and then Re-tendered.

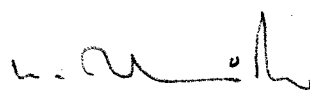

18. **OBSERVATIONS OF CWC- I HELD ON 27-09-2024:**

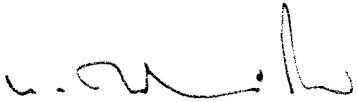

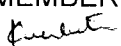
19. **DECISION OF CWC- I HELD ON 27-09-2024:**
